



Blue Recycling Dumpsters/Polycarts

Throughout the Installation, blue recycling containers are provided to collect commingled recyclable materials. You will find the recycling dumpsters next to brown trash dumpsters. Place all paper products inside a separate plastic bag with the top securely tied before putting the item in the recycling container. Never put yard waste or hazardous materials in the recycling containers. All commingled recyclables are processed by hand at the Fort Stewart Processing Station.



Recycling Stations

Set up a recycling station in your office, motorpool or barracks. Graphic imaging is available on the Environmental Division website and at the Multi-Media Visual Information Center (MVIC).

Shredded Paper/PII



We are Changing the Way You Recycle!

Fort Stewart/Hunter Army Airfield's (FS/HAAF) Waste Management Section is making recycling as easy as possible to encourage more participation. Several changes have been made in the recycling program recently as a result of the Installation's Sustainability Management System (SMS) objective to achieve a 50% reduction in generation and disposal of FS/HAAF non-hazardous solid waste by 2015. These changes are being implemented under the authority of the Installation Recycling Command Policy Letter which was signed on 15 FEB 07.



To assist with meeting the mandate, the DPW Environmental Division operates a Processing Station to segregate commingled recyclable materials. This facility is located off Wilson Avenue on Kilpatrick Road in route to the Fort Stewart landfill. Along with the facility, blue poly carts have been provided by Balfour Beatty Communities Ctr. to all Family Housing occupants and blue recycling dumpsters were placed throughout both Installations for the collection of commingled recyclable items.



The Processing Station

Vehicles that have a load of recyclables dump the materials onto a tipping floor. A loader transfers the materials into a hopper that is connected to a conveyor system. The conveyor moves the recyclable materials up and through a sorting line, where recyclables are hand sorted and dropped into separate bins below. Later, the materials are baled and processed for sale.

WHAT TO RECYCLE... GIVE PURPOSE TO THE BLUE DUMPSTER:

PAPER ITEMS

Junk Mail/Office paper, newspaper, magazines, includes inserts.

How:
Recycle in clear plastic bags.



GLASS/CANS/ALL PLASTIC

Bottles, jugs, grocery bags, egg cartons, shrink wrap, styrofoam, dinner ware (cups, plates, utensils).

How:
Rinse food from all plastic. Deliver packing p-nuts to Recycling Center (FS/Bldg. 1143, HAAF/Bldg. 727)



PRINTER INK /CARTRIDGES

Computers, printers, keyboards, telephones, batteries (tape both ends) No govt. equipment.

How:
Bring to scrap metal yard at:
FS: Italy St. (Bldg. 1143).
HAAF: Drop-off ctr. on Westley Ave. (Bldg. 727)



CARDBOARD BOXES

Shoe boxes, cereal boxes, microwave boxes.

How:
Breakdown and flatten all cardboard boxes.



Attn: 24-hour Convenience Centers are available for anyone living on or off post

FS: PX Parking Lot (Bldg. 71)
McFarland/Sigma St.

HAAF: PX Parking Lot (Bldg. 6020)
McArthur Circle (Bldg. 610)

Fort Stewart and Hunter Army Airfield along with all Federal Installations must reduce their waste 50% by 2015. Recycling at home and on the job is the easiest way to accomplish this requirement. Not only does recycling benefit our environment, but it is Mandatory.
